



**DUNDEE CORPORATION DECLARES QUARTERLY
FIRST PREFERENCE SHARES, SERIES 3 DIVIDEND**

Toronto, August 13, 2020 – Dundee Corporation (TSX: DC.PR.D) (“Dundee”) announced today that its board of directors has approved the payment of a quarterly cash dividend of \$0.27474 per cumulative floating rate first preference share, series 3 (“Series 3 Share”) payable on September 30, 2020 to shareholders of record on September 16, 2020. The quarterly cash dividend payable on September 30, 2020 is approximately \$0.08 lower than the amount paid in the previous quarter due to a reduction in the three-month Government of Canada Treasury Bill rate as reported by the Bank of Canada, on which the quarterly dividend per Series 3 Share is based.

The dividend is designated as an eligible dividend for the purposes of section 89 of the *Income Tax Act* (Canada).
